The deal was named "JOLCO Finance Deal of the Year 2018 – Europe". The aircraft was leased to SAS Group's own asset management affiliate Gorm Asset Management. The Japanese equity was arranged by Asset Brok'Air International. Charles's team included Associates Lucy Todd, Natasha Seel and Trainee Solicitor Jacob Southgate.
