

Launched on 19 October 2021, GARI offers a comparative index of 55+ restructuring procedures available in 30 key aviation jurisdictions. Freely available to all aviation sector participants, GARI presents information visually through infographics and assigns debtor and creditor 'friendliness' scores to complex restructuring procedures in order to make high-level comparisons easy to digest.

GARI had well over 2,000 unique users in the first six weeks of its launch and now has a steady userbase of over 60 unique users a day.

WFW Global Aviation Sector Co-Head Jim Bell, one of GARI's key developers, commented: "Given GARI's impressive use to date, we're very pleased to have added four key new jurisdictions to the tool, further enhancing its use to aviation participants in analysing and comparing restructuring procedures worldwide".
