

## WFW WINS EUROPEAN COMMISSION (DG MOVE) TENDER FOR MOBILITY AND TRANSPORT

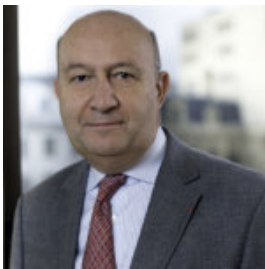
