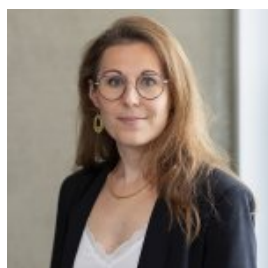

L'opération reste soumise à l'accord des autorités compétentes.

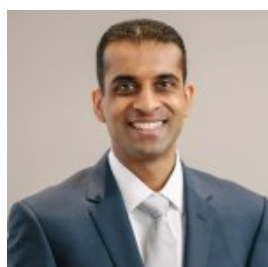

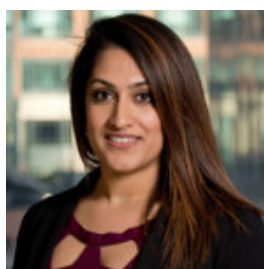
