

## WFW CONTINUES TO EXCEL IN ENERGY AND INFRASTRUCTURE LEAGUE TABLES

In addition, the firm received ten new rankings one of which was the top spot for deal count, Project Finance, Italy.

WFW's *IJGlobal* rankings saw notable improvements, particularly in the infrastructure space, which saw a rise from 15th to 10th place for Global Infrastructure, a huge leap from 37th to 18th place for Transport Infrastructure and a new ranking for MENA Infrastructure.

Rounding up, *inspiratia* saw the firm ranked second place by deal count and take top spot for the highest total disclosed transaction volume.
